THIS MEMORANDUM OF UNDERSTANDING (hereinafter referred to as "MOU") is made and entered into on the 27th day of January 2023.

BETWEEN

1. Admissions (GAUS):

2. COURSE & DEGREE REQUIREMENTS:

- All admitted students of SPP employees and/or their children shall be bound to follow course and degree requirements as prescribed in the prospectus and any issue from time to time by regulatory bodies and/or GAUS.

3. Disciplinary Policy:

- All admitted students of SPP employees and/or their children shall be bound to follow the discipline policy of the GAUS and any instructions issued from time to time in this regard. In any instance, the decision of the Disciplinary Committee (DC) shall be final and applicable.

4. WITHDRAWAL OF CONCESSION:

- The concession shall be withdrawn from the student in an instance of a serious breach of 3 (course & degree requirements) and 4 (Disciplinary policy) other than the penalties/repercussion of the said Requirement and policies.

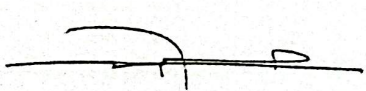
4. WITHDRAWAL OF CONCESSION:

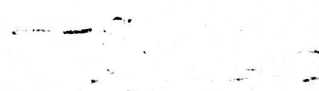
