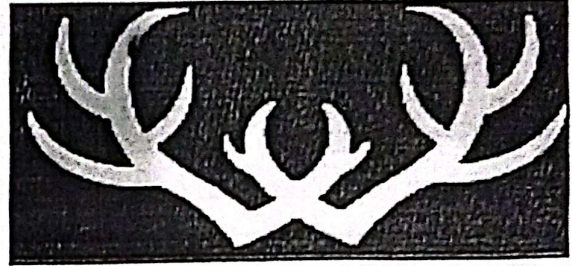

BETWEEN

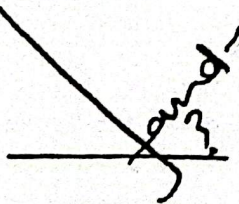
OBJECTIVES: -

- PBBMA will be invite faculty and students of GAUS in every event that will be related to wild life department.

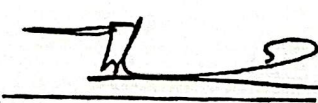
